# **Electronic File Submission**

Quality reproduction is subject to quality of materials received. The following file types are accepted:

- PDF (strongly recommended) Optimized for Press (high resolution). Embed 100% of fonts used. Allow a 3 pica bleed where applicable.
- TIFF or EPS Include fonts and links with eps files. Type should be converted to outline.
- CD or zip disks accepted.
- All ads must be accompanied by a printed laser or color proof.

## **Credit & Commissions**

- Agency commission of 15 percent is granted to recognized ad agencies. SJ FIRST will consider advertisements from firms that have a direct business relationship with the AAA South Jersey club or those that offer a special benefit to the Club's members.
- All payments are due 30 days after the date of invoice. Make all checks payable to AAA South Jersey.
